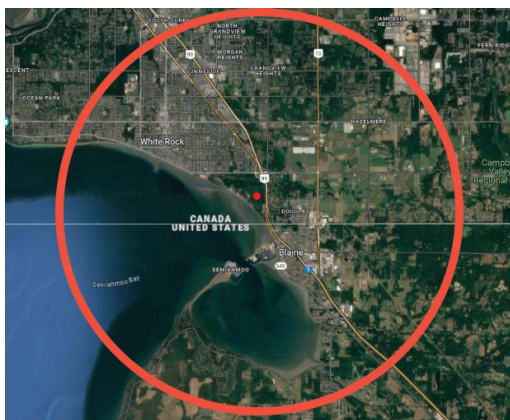


SAY **NO** TO THE SEMIAHMOO RNG GAS PRODUCTION & REFINERY PROJECT

Andion Global Inc.-Taurus RNG's Public Information and their Air Dispersion Modelling Report raises significant environmental and health concerns.

THEY SAY: "No noise or odour impacts to surroundings"

Their own Air Dispersion Modelling shows that there will be significant pollutants and odour released by the facility including Methane, Volatile Organic Compounds, Hydrogen Sulphides, Nitrogen Oxides and more. Hydrogen Sulphide emissions exceed health-based quality standards.

THEY SAY: "Abatement of nearly 1.5 M tons of waste that would otherwise end up in landfills or incinerators...there is less processing capacity in the region than organics that are collected"

- The City of Surrey Biofuel Facility can process 115,000 tonnes of material annually and is not at capacity.
- The Delta GFL Composting Facility can process 150,000 tonnes annually and is taking all the material from municipalities including Vancouver and Burnaby.
- Construction is already underway at the Vancouver Landfill in Delta for another RNG Facility.

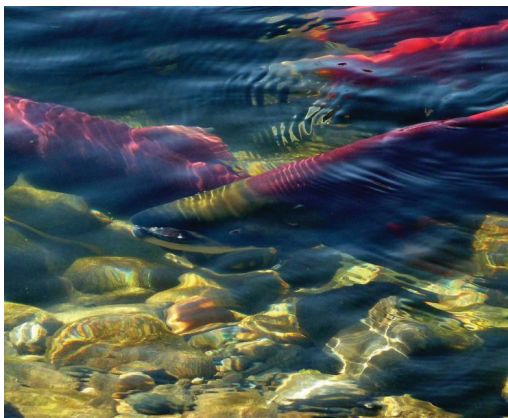

THEY SAY: "50% of individuals can smell an odour that is rated at 1 OU".

Their Air Dispersion Modelling Report shows that there might be up to 6 times a month when the smell reaches a level of 10 OU. If 50% of the normal population can detect an odour at 1 OU, what is 10 OU going to smell like? Even more concerning is that odour directly correlates to pollutants in the air.
